

PRESIDENT'S MESSAGE Elliott R. Futrell

I am proud to report to you that you have a very hard working volunteer Board. We have made some critical decisions this year as we attempt to control costs and keep the dues at a reasonable level. We have switched all of our printing accounts to the School of Graphic Arts in Oxford, NC. The journals in the past have been saddlestitched, but in the future they will be perfect bound. Using this and other cost cutting measures, the Board has been able to reduce publication expenditures on the Journal and NCGS News to almost half of what they were. I share this information with you to keep you informed of the stress that the Board has endured as it attempts to manage your Society in your best interests.

I would like to share with you what I am doing in genealogy. I have been reviewing my 40 years of research, making sure I clean up my mistakes. As I proceed, I try to make sure each person is well documented. This is the main reason I have not been to the State Archives lately. Debbi Blake wondered why she had not seen me there and asked me whether I was doing any research. I told Debbi that I did not see any need for finding additional information when I had piles and boxes of research that I hadn't yet integrated into my computer files. This has all been fun for me because I have found information I had forgotten I had, and it will often lead me to other persons in the family. I am hoping that, as I proceed, I will find information that I had overlooked and which will help me overcome brick walls in my two main family lines.

When you start going back over your information, you find that, years ago, you made some mistakes that were very petty. It is almost unbelievable that I could have ever been so naïve or ill-informed. Yet, there it is in black and white. I have been so careful in the past few years, trying to be sure that I document each person. I enter any other information I can find on my family into the note section under each individual. I am hoping one day to publish a book on my two main family lines and I may be able to do the same for some of the other allied lines, if only I live long enough.

I would like to introduce the Society membership to a very special member-- Ann Hilke. She lives in Raleigh and has worked very hard for your Society on the program committee. The committee organized an outstanding workshop in July with Old Buncombe County Genealogical Society in Asheville. George Morgan is a very good speaker and if you missed this workshop, you missed an excellent chance to expand your knowledge of genealogy. Ann Hilke has accepted the position of program chairman for the rest of my term in office. I ask you to give her your support, as you have done for Ann Basnight. I would like to thank Mrs. Basnight for chairing the committee for two and one half years. Ann Hilke and Ann Basnight have an excellent workshop planned for November at the Annual Meeting. Please mail vour registrations in early to ensure a place at this event. I am looking forward to seeing old friends and meeting new ones at this Annual Meeting.

NCGS STATEMENT CODE OF ETHICS

The North Carolina Genealogical Society encourages researchers to uphold high standards for their genealogical research, analysis, and publication. Care should be taken to document properly all information included in a genealogical work. Researchers should remember that the original document is the proper source for all information.

When the original cannot be found, careful analysis of secondary materials (including Internet sites) should be fully explained and sources cited.

Given modern technology and the ease of accessing information on the Internet, researchers are encouraged to respect the privacy of all living individuals by not sharing personal information via electronic media. While the courts have not yet fully tested copyright issues involving the Internet, the same respect should be paid to information found on the Internet as is paid to information found in printed works bearing notice of copyright. Under United States copyright law, an individual's intellectual output is protected whether or not it bears a copyright notice or symbol and regardless of the medium in which it appears.

NCGS encourages and expects its members to uphold high moral standards in their use of electronic media, in their research, and in their interaction with fellow genealogists and other persons. Ethical behavior by individuals will reflect well upon our organization, as well as the field of genealogy.

NCGS has begun a project to collect and preserve family records (appearing in Bibles or in other record books) pertaining to persons who were at one time North Carolina residents. NCGS members and all others with North Carolina connections are invited to participate. Collected records will be published in either CD or book form. A prepublication sale will begin at the end of the submission period. <u>DEADLINE for submission: 31 Dec 2004.</u>

CRITERIA for inclusion:

- Each record must have at least one entry of a person being born, dying or marrying in N.C. prior to 1920.
- May appear in a Bible or any other record book, but please, no compiled family histories. We are looking for primary source material.
- All submitted materials become the property of NCGS and will not be returned!
- There is no cost for inclusion, whether or not you are a member. There is no limit on the number of entries, so get a friend to submit!

PROCEDURE for submission.

- Please provide a readable photocopy of the pages with the family record and of the pages with the title and publication information of the Bible.
- Put a correct address label on the back of each copy submitted.
- Provide a typewritten or legible printed transcription of the record.
- If the Bible is too fragile to photocopy, a transcription alone is sufficient, but, in that case, carry the original to
 a notary public and have him/her to compare and notarize the transcription. (See below.)
- You MUST provide the contact information for the owner of each record below. If the owner wishes to
 remain anonymous in the publication, check the appropriate box below the contact info below.
- Owner MUST sign a permission to print for each record submitted. (See below.)

Additionally, copy machines and submission forms will be available for your convenience at the Summer Regional Workshop in Asheville (10 July 2004) and at the Annual Meeting and Workshop (12—13 Nov 2004) in Raleigh. 

Cabarrus County was formed in 1792 from Mecklenburg County and was named in honor of a North Carolina politician, Stephen Cabarrus of Edenton.¹

Concord is the county seat of Cabarrus County, which is located in the south-central part of North Carolina. This county is bounded by Stanly, Union, Mecklenburg, Iredell and Rowan Counties.

An interesting point I learned when looking up Cabarrus County in the *NC Gazetteer* was that this is the home of the Reed Gold Mine, the site of the first authentic discovery of gold in North Carolina.²

1798 FEDERAL TAX LISTS

Need help tracking down records for N.C.'s implementation of the 1798 Federal Direct

Tax. This would include: (1) the Particular Lists, forms A, B, and C, (2) the General Lists, forms D, E, and F, (3) the Summary Abstracts, forms G, H, I and K, and (4) the minute book or records of the proceedings of the N.C. Commission for the Valuation of Lands, Dwelling Houses, and enumeration of Slaves. The implementation of the tax was delayed in N.C., so the records could be dated as late as 1803. BY-LAWS CHANGES

At this year's Annual Meeting and Workshop, 13 November 2004, the following changes to the NCGS by-laws will be proposed for approval by the membership:

MOTION by Mrs. Hinton, second by Mrs. Basnight, to revise and replace Article V, Section 1, Annual Meeting to read "The annual meeting of the Society shall be held during the last quarter of the year in the State of North Carolina at a time and place designated by the NCGS Board of Directors and shall be held for the purpose of hearing reports of officers and committees, conducting the election of officers and the Nominating Committee, and conducting any other business that may properly come before the Society." Motion carried.

MOTION by Mrs. Tetterton, second by Mrs. Basnight, to add "representative of North Carolina" to Article IV, Section 1, Designation and delete Article IV, Section 2 in its entirety. Motion carried. If passed by the membership, Article IV, Section 1 will read: "The officers shall be a President, a First Vice President, a Second Vice President, a Secretary, a Treasurer, currently functioning Past President and six Directors representative of North Carolina.

ROSE O'NEAL GREENHOW Part I Elizabeth Futrell

Rose O'Neal Greenhow, a Confederate spy who claimed to have helped the South defeat the North at Bull Run and who spent time in prison for espionage, died in the same dramatic, edgy way that she had lived. On Oct. 1, 1864, she drowned off the coast of Wilmington, NC.

From an early age, Rose was described as an attractive and courageous person-and also a highly unpredictable individual, often referred to as "Wild Rose," a name that would certainly suit her throughout her life. Born to Irish immigrants in 1817, Rose O'Neal Greenhow spent her early years in Georgetown, MD, but when she was a teenager, she and her sister became orphans and were whisked away to live with their aunt, Mary Hill, who owned a fashionable boarding house on the corner of 1st and A Streets, a place that attracted many well-known politicians. The Old Capitol Boardinghouse introduced Rose to many influential men and sparked her interest in politics. She fell in love with Washington, DC, where she attended school during the Jackson era. During this period, she dated senators, cabinet members, foreign dignitaries and other men of wealth and power.

While living at the boarding house, Rose encountered Vice President John C. Calhoun, who had a reputation as a strong Southern sympathizer. Calhoun influenced Rose while giving a speech in which he said, "We are not a nation, but a union, a confederacy of equal and sovereign states." She credited Calhoun with shaping her political philosophy and sparking her interest in law. After his speech, she memorized the U.S. Constitution. His speech made such an impact on her that it would later lead her to a life as a Southern supporter, willing to take any risk or challenge for the cause.

But first came love and marriage. She married a lawyer, Robert Greenhow, who was from a well-known Richmond, VA family. Rose enjoyed entertaining and playing the hostess to politicians, their colleagues and friends at her home. In 1850, however, as the separation between the states of the Union and the tension of war was heavy in the air, Robert and Rose Greenhow moved to San Francisco, CA, with their three children, where Robert opened a law firm and settled land claims, thus taking Rose away from the political climate she loved. Shortly after they moved, though, Robert died suddenly as a result of a fall.

After this tragedy, Rose returned to Washington, DC, with her children and began working for the 15th president, James Buchanan. Her relationship with the bachelor president was described as an intimate one; they were known to take walks together and sit in the park and talk. Many were surprised that Buchanan never proposed marriage to Rose.

It wasn't a surprise, though, that Rose's many connections granted her eventual friendships with Jefferson Davis, who later became president of the Confederacy and Colonel Robert E. Lee, who once said to Rose, "Virginia is my country. I could never take up arms against my friends and family."

When Buchanan's presidency ended with the inauguration of Abraham Lincoln, Rose's job came to an end. She was then approached by Captain Thomas Jordan of Virginia who revealed to Rose that he was setting up a network of Southern sympathizers in Washington with the intention of keeping the Confederate government informed of Northern plans, and he wanted her help. A Southern sympathizer through and through, Rose accepted and her house in Lafayette Park across from the White House became the center of this informative network between the two points, Richmond and Washington. She created ciphers and codes, and she had an assembly of people working beneath her. Rose reported primarily to Captain Jordan and it has been said that her insider information had a great deal to do with the South's victory at the Battle of Bull Run.
