While not maintaining a library of its own, the society promotes and encourages the development of the many fine research centers across the state. Books given to the society for review in the *NCGS Journal* are donated to the Genealogy Collection of the State Library of North Carolina in Raleigh, North Carolina.

NCGS Statement Code of Ethics

The North Carolina Genealogical Society encourages researchers to uphold high standards for their genealogical research, analysis, and publication. Care should be taken to document properly all information included in a genealogical work. Researchers should remember that the original document is the proper source for all information.

When the original cannot be found, careful analysis of secondary materials (including Internet sites) should be fully explained and sources cited.

Given modern technology and the ease of accessing information on the Internet, researchers are encouraged to respect the privacy of all living individuals by not sharing personal information via electronic media.

While the courts have not yet fully tested copyright issues involving the Internet, the same respect should be paid to information found on the Internet as is paid to information in printed works bearing notice of copyright. Under United States copyright law, an individual's intellectual output is protected whether or not it bears a copyright notice or symbol and regardless of the medium in which it appears.

How to Avoid Being Duped by the Internet

The Internet brings increasingly bountiful amounts of information to genealogists' desktops—some valid, some erroneous, and much of unknown accuracy. Attendees will learn practical strategies for discriminating between correct and misleading information. They will also learn how online information—even if its accuracy is unknown—can lead to valid conclusions about ancestors.

Solving the Mystery of the Disappearing Ancestor

Genealogists may be frustrated by not finding ancestors in the records and places where they logically expect them to be. This presentation will explain seven reasons why such ancestors seem to have disappeared, provide examples of each from actual case studies, and suggest strategies to help attendees find their elusive ancestors.

Organizing Evidence to Overcome Record Shortages

Genealogists are often frustrated by record shortages and surviving records that do not specify relationships. Using the analogy of assembling a jigsaw puzzle with many missing and damaged pieces, a case study will demonstrate six steps to bypass record shortages and identify ancestors successfully.

Seven Habits of Highly Effective Genealogists

Using standards articulated in the *BCG Genealogical Standards Manual* (Orem, Utah: Ancestry, 2000), the session explains and provides examples of seven ways attendees can achieve research results that are both accurate and useful.

Thomas W. Jones, PhD, CG, CGL, FASG, FNGS, has edited the *National Genealogical Society Quarterly* since 2002. He is a trustee and a past president of the Board for Certification of Genealogists, past board member of the Association of Professional Genealogists, and recipient of its 2011 Professional Achievement Award and its 2004 Grahame T. Smallwood Jr. Award of Merit.

Retired from a thirty-year career in higher education and professor emeritus at Gallaudet University in Washington, DC, Tom works full time as a genealogical researcher, writer, editor, and educator. He coordinates courses at the Genealogical Research Institute of Pittsburgh, the Salt Lake Institute of Genealogy, and Samford University's Institute on Genealogy and Historical Research; and he teaches in Boston University's Genealogical Certificate Program. Tom's research has encompassed records of every state east of the Mississippi, as well as Iowa, Kansas, Missouri, Texas, England, France, Germany, Italy, Ireland, and Wales. He specializes, however, in Georgia and Virginia and is most interested in solving "brick-wall" genealogical problems.

Tom writes and speaks frequently on genealogical methods with broad application across geographic areas, time periods, and levels of expertise. He is known for meaty lectures benefiting genealogists of all experience levels.

2012 NCGS Awards

Among the most rewarding of NCGS programs is its annual presentation of awards to honor outstanding efforts in publishing and contributions to the North Carolina genealogical community. These awards additionally serve not only to promote continued excellence in this field but also to inspire others to publish abstracts and transcriptions of North Carolina county and state records, cemetery and Bible records, family histories, and society journals and newsletters, and to develop informative genealogical websites. The Awards Committee urges you to join the society in recognizing the labors of deserving individuals and societies by submitting a nomination for an award in one of several categories.

The NCGS awards nominations are open from January until 15 August 2012. The categories for the 2012 NCGS Awards are as follows:

- **1.** THE AWARD FOR EXCELLENCE IN PERIODICAL PUBLISHING for a periodical (newsletter) published by a local North Carolina genealogical society.
- **2.** THE AWARD FOR EXCELLENCE IN PERIODICAL PUBLISHING for a periodical (journal) published by a local North Carolina genealogical society.
- **3.** THE AWARD FOR EXCELLENCE IN WEB PRESENCE for excellence in web presence for a freely accessible website promoting North Carolina genealogy.
- **4.** THE AWARD FOR EXCELLENCE IN PUBLISHING for a book, or a set of books, of abstracts or transcriptions of original North Carolina primary source material and published within eighteen months preceding the award (15 April 2011–15 October 2012).
- **5.** THE AWARD FOR EXCELLENCE IN PUBLISHING for a book of secondary source material relevant to North Carolina and published within eighteen months preceding the award (15 April 2011–15 October 2012).

- **6.** THE AWARD FOR EXCELLENCE IN PUBLISHING for a book of family history relevant to North Carolina and published within eighteen months preceding the award (15 April 2011–15 October 2012).
- 7. THE AWARD FOR OUTSTANDING CONTRIBUTION TO NORTH CAROLINA GENEALOGY for an individual whose outstanding genealogical contributions have greatly enhanced the study of family history in North Carolina. The genealogical contributions may be regional.
- **8.** THE AWARD FOR OUTSTANDING CONTRIBUTION TO NCGS BY A MEMBER for an individual whose work within the NCGS has been outstanding.

Each submission requires a Nomination Form (see page 7) that should be mailed to NCGS Awards, PO Box 30815, Raleigh, NC 27622-0815. A copy of any publication being nominated must accompany the submission as well as complete contact information and any relevant supporting material, data, or additional written endorsement. Please include the latest four (4) issues of a nominated newsletter or journal. Closing date for submissions is 15 August 2012.

Nominations are reviewed by a panel of judges, and awards will be presented during the NCGS Annual Meeting to be held on 13 October 2012. Printed materials should properly cite their sources. Submissions of printed material are donated to the State Library of North Carolina in Raleigh after the judging process. North Carolina Newspapers Research Easier with the NC Newspaper Locator

What newspapers were published in or near Brevard, North Carolina, in 1910? That's a big question and if you've ever had to try to answer it, you know that you are in for a little research. Well, the Government & Heritage Library at the State Library of North Carolina just made that question, and others like it, easier to answer.

The North Carolina Newspaper Locator database (http://cinch.nclive.org/newspaper/), reflecting the microfilm holdings of the Government & Heritage Library, contains listings for nearly 2,000 unique newspaper titles dating from 1751 to today. Free to all, and of particular interest to North Carolina genealogists and historians, this database locates newspapers in time and geographic space. Users can search for titles by specific counties or those surrounding them, city, date or date range, or by a newspaper title itself. Once a newspaper has been located, users may request the microfilm reels through their local library's interlibrary loan service. We lend newspaper microfilm to libraries throughout the continental United States.

The power in the database lies in the ability to expand a county search to neighboring counties. For example, genealogists looking for marriage and death newspaper announcements may know where an ancestor lived, but that doesn't mean finding the announcements is straightforward. The NC Newspaper Locator searches not only by city, but also automatically by county. And, it gives users the option to expand their search to all surrounding counties. This gives a researcher more time to spend perusing appropriate newspapers for family information.

So, what about 1910 Brevard, North Carolina, newspapers? A quick search of the NC Newspaper Locator finds that the *Sylvan Valley News* was published in Brevard, in Transylvania county, from 1900 to 1916. Even better, at least five other newspapers were published in the North Carolina counties surrounding Transylvania in that same year (*Asheville Gazette-News, French Broad Hustler, Waynesville Courier, Western Carolina Enterprise*, and *Western North Carolina Times*).

NCPedia Adds 24,000 New Articles

North Carolina Department of Cultural Resources Secretary Linda A. Carlisle recently unveiled a partnership between the State Library of North Carolina and UNC Press to make the six volumes of the *Dictionary of North Carolina Biography* and the *Encyclopedia of North Carolina*, some 24,000 articles in all, available as part of the Web site NCPedia.org. The free online encyclopedia features articles and resources about North Carolina culture and history.

"The goal of NCPedia has always been to make cultural information available for a wide range of users—teachers, students, business and civic organizations, cultural groups, and decision makers," said Carlisle. "The Department of Cultural Resources is committed to digitization, and this exciting partnership with UNC Press is a great leap forward as we continue to record and interpret North Carolina's rich history and culture."

The Encyclopedia of North Carolina and the multivolume Dictionary of North Carolina Biography were edited by William S. Powell, professor emeritus of history at UNC-Chapel Hill, and published by UNC Press. Founded in 1922, UNC Press is the oldest university press in the South and one of the oldest in the United States.

"This is a moment William Powell, all of us at UNC Press, and our many friends around the state have dreamed about for years," said Simpson-Vos. "The Encyclopedia of North Carolina and the Dictionary of North Carolina Biography are veritable treasure troves of information about our state, and UNC Press is delighted to be partnering with the State Library of North Carolina to bring these articles to the public as part of NCPedia."

The State Library has already received the files digitally and has begun the process of integrating content and making it available online. The project is expected to take three years.

The deadline for the next issue of the NCGS News is Sunday, 15 April.

To date, the letter A has been finished and B is in progress. Digital documents that are copyright-free are full text searchable in the North Carolina Family Records Online collection at http://digital.ncdcr.gov.

Copyrighted documents will soon be available for similar full-text searching onsite at the State Library.

In addition, the State Library is asking for *your* help in transcribing some of the hard-to-read and handwritten documents. It's easy—just head to the library's flickr account online at http://www.flickr.com/photos/statelibrarync/, set up an account if you don't already have one, find an image that needs to be transcribed, and type in as much or as little as you can in the image's comment box. Your work will help researchers like you search documents more quickly and accurately.

FamilySearch Wants You to Help Index the 1940 Census

On 2 April 2012, NARA will provide access to the images of the 1940 United States Federal Census for the first time. Unlike previous census years, images of the 1940 US Federal Census will be made available as free digital images.

Upon its release, the 1940 US Census Community Project, a joint initiative between Archives.com, FamilySearch, findmypast.com, and other leading genealogy organizations, will coordinate efforts to provide quick access to these digital images and immediately start indexing these records to make them searchable online with free and open access.

The 1940 US Federal Census is the largest, most comprehensive, and most recent record set available that records the names of those who were living in the United States at the time the census was taken. 132 million people were living in the 48 Continental United States in 1940. Tens of millions of people living in the United States in 1940 are still living today, making this a record set that connects people with recent family records.

Many of these individuals are part of what has been called the greatest generation. The people in the 1940 census deserve to have their records preserved and made available online.
