You won't want to miss the upcoming Seventh Annual Speakers Forum to be held on Saturday, 30 June 2012, at the Wake County Commons Building in Raleigh. NCGS is working with the Olivia Raney Local History Library to offer this event.

This year, seven genealogists and librarians will speak on topics that range from ways to enhance basic genealogical techniques to more advanced use of the Internet for state-of-the-art approaches to genealogical research. Plans are being made to have two sets of presentations during each of the four hour-long sessions so you can choose the topic that best fits your needs. The exact schedule with the time for each lecture will be announced on the NCGS website as soon as it is finalized.

Vendors are being invited, and plenty of time between sessions will be available to browse among their offerings and to speak with them about your research needs.

The registration fee is \$35 for members and \$45 for non-members. An optional box lunch can be ordered for \$9. Lunches must be ordered by June 18. If you desire a vegetarian lunch, you may order one on the registration form.

Society Goals

The North Carolina Genealogical Society, chartered in 1974, is open to all who are interested in genealogical or historical research and in these goals:

- to increase interest in and raise the standards of research and compilation by means of educational programs and publications;
- to acquaint members with research sources and materials in North Carolina and elsewhere;
- to serve as a medium of exchange of genealogical information; and
- to promote the collection, preservation, and utilization of manuscripts, documents, and other materials of genealogical and historical value.

While not maintaining a library of its own, the society promotes and encourages the development of the many fine research centers across the state. Books given to the society for review in the *NCGS Journal* are donated to the Genealogy Collection of the State Library of North Carolina in Raleigh, North Carolina.

NCGS Statement Code of Ethics

The North Carolina Genealogical Society encourages researchers to uphold high standards for their genealogical research, analysis, and publication. Care should be taken to document properly all information included in a genealogical work. Researchers should remember that the original document is the proper source for all information.

When the original cannot be found, careful analysis of secondary materials (including Internet sites) should be fully explained and sources cited.

Given modern technology and the ease of accessing information on the Internet, researchers are encouraged to respect the privacy of all living individuals by not sharing personal information via electronic media.

While the courts have not yet fully tested copyright issues involving the Internet, the same respect should be paid to information found on the Internet as is paid to information in printed works bearing notice of copyright. Under United States copyright law, an individual's intellectual output is protected whether or not it bears a copyright notice or symbol and regardless of the medium in which it appears.

2012 NCGS Awards 2nd Notice

The deadline for submitting nominations for NCGS Annual Awards to honor outstanding efforts in publishing and contributions to the North Carolina genealogical community is getting near. This year's deadline comes sooner—15 August 2012—with the society's annual fall meeting being scheduled earlier than previous years.

These awards promote continued excellence in this field and also inspire others to publish abstracts and transcriptions of North Carolina county and state records, cemetery and Bible records, family histories, and society journals and newsletters and to develop informative genealogical websites. The Awards Committee urges you to join the society in recognizing the labors of deserving individuals and societies by submitting a nomination for an award in one of several categories.

The categories for the 2012 NCGS Awards are as follows:

- **1.** THE AWARD FOR EXCELLENCE IN PERIODICAL PUBLISHING for a periodical (newsletter) published by a local North Carolina genealogical society.
- **2.** THE AWARD FOR EXCELLENCE IN PERIODICAL PUBLISHING for a periodical (journal) published by a local North Carolina genealogical society.
- **3.** THE AWARD FOR EXCELLENCE IN WEB PRESENCE for excellence in web presence for a freely accessible website promoting North Carolina genealogy.
- **4. THE AWARD FOR EXCELLENCE IN PUBLISHING** for a book, or a set of books, of abstracts or transcriptions of original North Carolina primary source material and published within eighteen months preceding the award (15 April 2011–15 October 2012).
- **5.** THE AWARD FOR EXCELLENCE IN PUBLISHING for a book of secondary source material relevant to

North Carolina and published within eighteen months preceding the award (15 April 2011–15 October 2012).

- **6.** THE AWARD FOR EXCELLENCE IN PUBLISHING for a book of family history relevant to North Carolina and published within eighteen months preceding the award (15 April 2011–15 October 2012).
- 7. THE AWARD FOR OUTSTANDING CONTRIBUTION TO NORTH CAROLINA GENEALOGY for an individual whose outstanding genealogical contributions have greatly enhanced the study of family history in North Carolina. The genealogical contributions may be regional.
- **8.** THE AWARD FOR OUTSTANDING CONTRIBUTION TO NCGS BY A MEMBER for an individual whose work within the NCGS has been outstanding.

Each submission requires a nomination form (see page 7) that should be mailed to NCGS Awards, PO Box 30815, Raleigh, NC 27622-0815. A copy of any publication being nominated must accompany the submission as well as complete contact information and any relevant supporting material, data, or additional written endorsement. Please include the latest four (4) issues of a nominated newsletter or journal. Closing date for submissions is 15 August 2012.

Nominations are reviewed by a panel of judges, and awards will be presented during the NCGS Annual Meeting to be held on 13 October 2012. Printed materials should properly cite their sources. Submissions of printed material are donated to the State Library of North Carolina in Raleigh after the judging process. Volunteer Corner



At the Genealogy Done Right workshop on 31 March 2012, Dr. Thomas W. Jones presented a lecture entitled "Organizing Evidence to Overcome Record Shortages" in which he used the analogy of assembling a jigsaw puzzle when doing genealogy research. The puzzle pieces of evidence we find as we search various records for our ancestors must eventually be assembled into a picture of our family. The more puzzle pieces we find that fit, the more complete and accurate the picture we assemble of our family will be. NCGS is very much like a puzzle with the officers, Board of Directors, committee chairs, members, and volunteers fitting their puzzle pieces together to make a picture. The more puzzle pieces we have, such as volunteers willing to give of their time to help the society with its mission, the more complete the NCGS picture will be, thus creating a stronger organization. You can help fit in missing puzzle pieces by volunteering for one of the opportunities below:

If you are planning to register for the workshop consider helping in one of the following ways:

- AV Assistant: Meet with AV tech for the building early that morning to learn operations of their LCD projector, computer, and sound system. Work with speakers to load their PowerPoint files. Be on hand during the sessions to troubleshoot and/or adjust the volume of the sound system or to contact the building's AV tech, if necessary.
- Greeter: Stand in hallway, near the meeting rooms, during registration and the morning breaks to point attendees to the lecture and vendor rooms as well as the restrooms. Need to arrive early to get in position.
- Packet Stuffers: Meet at a location in Raleigh designated by the Program Chair, to prepare the

- packets for the workshop. This will most likely be done in the afternoon before the workshop.
- Refreshment Servers: Arrive early to get refreshment tables set up; replenish before breaks.
- Box Lunch Distributor: Assist with handing out box lunches to those who purchased them.
- NCGS Sign Handler: Obtain the orange directional signs from the person storing them. Set them up in strategic locations very early on the morning of the workshop. Remove the signs at the end of the workshop and deliver to the person storing them.
- Room Monitor: Start each session on time.
 Introduce the speaker by announcing his/her name and lecture title. Signal the speaker when five minutes are left (if s/he desires such help). End each session on time.

- Submit carefully researched and well-documented case studies and methodology articles as well as source material and fillers.
- Submit transcriptions and abstracts of original documents of North Carolina genealogical significance.
- Act as a second reader to help decipher difficult signatures in North Carolina legislative petitions at the North Carolina State Archives, once per quarter.

Loose Estates Indexing Project

• In conjunction with FamilySearch and the North Carolina State Archives, create a decedent surname index of all extant loose estate records. This can be done from the volunteer's home with Internet access. Training is provided.

Research War of 1812 at Rhodes Room Catawba County Library System, Newton, NC

The Rhodes Local History Room at the Catawba County Library has a number of resources available for those seeking ancestors who served during the War of 1812.

This bicentennial year is producing more interest in this "forgotten war" with Britain—a conflict we almost lost. Sparked by a struggle over maritime rights, the war began 18 June 1812 and resulted in a failed attempt to invade and wrestle Canada away from British control. America was ill-prepared for the war, which resulted in the partial burning of Washington, DC. The aftermath brought about armories across the country as well as a clear boundary between the US and Canada.

Did you have ancestors in the conflict? A number of sources in the Rhodes Room can help you find out. Among the reference volumes are *Index to War of 1812 Pension Files* Vols. 1–3, *Muster Rolls of the Soldiers of the War of 1812: North Carolina* and *1812 Ancestor Index*, Volumes 1–3, to name three.

Other print resources and online databases can help you research the question about relatives who may have served between 1812 and 1814. If you're new at the genealogy game, staff members are available to help.

Everything's on the Internet?

"Isn't everything on the Internet?" No, but FamilySearch is working hard to change that and to provide the records we need to find our ancestors. If you haven't visited http://www.FamilySearch.org yet, check it out. The digitized images are free.

The FamilySearch homepage opens up to "Discover Your Family History." Type a name into the fields and click the Search button. A search from this page is worldwide unless you select certain parameters, such as dates and places. Search results could be displayed for a variety of places and perhaps an unexpected clue can be discovered using this method of searching. Although I am delighted with positive results, I also like to know which records were searched that yielded no results. Because of this, I prefer to search record sets individually.

Not all of the available records on FamilySearch have been indexed but some individual record sets have their own indexes. To locate these records, scroll down on the FamilySearch home page to "Browse by Location" on the left-hand side of the page. Double click on "United States." On the next screen, under "Place" in the left hand column, choose the state whose records you want to search. For a federal record, like the United States census, click on "United States" and a list of federal records will come up. In our case, click on "North Carolina" and a list of North Carolina records that have been digitized and/or indexed will appear. The list currently includes the following titles:

A camera icon next to the title of the record indicates there are images available. If there is no camera icon, there are no images, but the information provided about the record set can be very helpful. Click on "Learn more" and you will move to a FamilySearch Wiki page that gives a more in-depth description of the collection and research tips.

When a digitized record set does not have an index, you can browse the images. As an example, click on "North Carolina Probate Records 1735-1970" and a page will appear that explains what the collection is. To see the record images, click on the browse link below "View Images in this Collection." (As of 15 April there were 1,145,307 images of North Carolina probates in this collection.) You won't actually have to browse all the images because you can narrow your search on the next screen where a list of counties will appear. Click on the county of interest; the next screen will display a list of records. Choosing "Orange County" and then "Settlements 1868–1882," I finally came to the images! The images will be tiny, so be sure to zoom in. To navigate to another image in the settlement book, an image number can be typed in the image box, or, if you would like to move ahead or behind one image at a time, use the arrows on the top right-hand side of the image box. By moving one page at a time, I discovered an index to the book. From the index, a page number can be found for the settlement of your ancestor's estate, or perhaps you will discover that nothing is in the volume for Grandpa.

If file and print is clicked to print a page, the image will be very, very small. To print a normal-size page, right click on the image, select "Save Image As ..." and choose a location to save it on your computer. You can then print from this file. Following this procedure provides the best print results.

More and more images, both national and international, are being added every month. Check out FamilySearch's record collections. Maybe, eventually, everything will be on the Internet?
