OAKLEY, John Baker, 1803-1864. Married Nancy Carver in 1826 in NC. They are buried in Person County. Unable to locate him in Person County. NC, prior to 1830 and cannot find his parents.

MITCHELL, Robert Thomas, b.1826 in Person County, NC. Married Elizabeth Sarah Long in 1857. The 1860, 1870, <u>added from Benson Museum of Local History and More Photos From the Benson Museum of Local History.</u>

# Moore County, North Carolina of the by Terry Moore, CG

We have all heard the expression "more is less" and nowhere is that more appropriately applied than to Moore County, North Carolina, where a courthouse fire in 1889 destroyed most of its records. As recorded in the 12 September 1889 newspaper, *The Carthage Blade*, "The loss from this office [clerk's office], was about 500 judgment rolls, all probate papers, most of the old court minutes and dockets, all guardian books and bonds, all administrator's bond books, all Supreme Court Reports and Acts of the Legislature. All other books and papers are saved. Every paper and book in the Register's office, including the 1889 tax books (which had not yet been quite finished) was lost. So was everything in the County Superintendent's office also lost." A full account of the fire can be found in the May 1989 issue of the *NCGS Journal*. <sup>1</sup>

Moore County was formed in 1784 from Cumberland County. In 1850 and before, Moore County bordered Cumberland, Richmond, Montgomery, Randolph, and Chatham counties. Although somewhat bleak, below is a list of the records before 1850 that survived. Other early records of Moore County residents can be found in public and church newspapers, early divorce records, runaway slave advertisements, Supreme Court cases, federal tax lists, and other compilations of records that were not in the Moore County Courthouse that somber night. Many of these are abstracted in the NCGS Journals.

CARSON, Ameriah, b. 1810 in VA. Married Zilpha \_\_\_\_\_. They had a child named Henrietta Carson, b. 1846 in WV; d. 1903 in Edenton, NC. Looking for anything on them.

BEAN, Major William (name, not title), 1866-1916. Married Margaret (Maggie) Sarah Powlass in 1885 in Franklin Township, Rowan County, NC. Looking for his father.

As Local Host Chair for the NGS 2017 Family History Conference in Raleigh, 10-13 May 2017, the theme, Family History Lives Here, is reflective of the fact that genealogy and family history pursuits in North Carolina are inclusive of all, regardless of race, color, religion, age, national origin, sex, sexual orientation, gender identity, or disability. The Board respects the individual right of every NCGS member to exercise freedom of thought and action with regard to the North Carolina law.

We were pleased to see that the Wake County Commissioners have also pledged their commitment to inclusion, stating that "County employees and applicants cannot be discriminated against based on race, color, religion, sex, national origin, age, disability, genetics, veteran status, sexual orientation, gender identity or expression, family status or political affiliation. As a board and as a county, we remain committed to those principles."

NCGS supports the National Genealogical Society's practice in not contracting with hotels and convention centers that discriminate, and the Board of Directors has sent a letter of concern to the Raleigh Convention Center and our conference hotels, asking that they help ensure Raleigh is a safe and welcoming location for all of our 2017 conference attendees. Board volunteers will endeavor to ensure that every effort is made for our friends, colleagues, and guests to have an enjoyable experience.
