Surviving Buncombe County, North Carolina, County Records

Asheville, North Carolina, and the awe inspiring Biltmore Estate are located in Buncombe County, which was created in 1791 from Burke and Rutherford Counties. A number of counties were created from Buncombe including Haywood, Yancey, Henderson, and Madison. Buncombe County was named after Colonel Edward Buncombe, a Revolutionary War soldier.¹ The courthouse fires of 1830 and 1865 destroyed many records including many early court records. The Old Buncombe County Genealogical Society is an active society with a History and Family Research Center in Ashville located at 128 Bingham Road, Suite 950. Nancy Manning is the Historian/Genealogist.

- Genealogy Inc., <u>http://www.genealogyinc.com/</u> <u>northcarolina/buncombe-county</u>, has a great list of online links for Buncombe County.
- Pam Toms, retired Genealogy Reference Librarian at the North Carolina State Library, recommends the Speculation Lands Collection website from UNC-Asheville (http:// toto.lib.unca.edu/findingaids/mss/ speculation_lands/biographies/tench_coxe.htm). From 1795-1797, Tench Coxe acquired 400,000 acres of land in McDowell, Henderson, Buncombe, Polk, and virtually all of Rutherford County. The site has maps, plats, land grant descriptions, and surname and geographic indexes. This is a site you must explore for land records in the above counties.

Remember to search the FamilySearch catalog for records not online that you want to access. They may be on microfilm, which is available to rent and use at your nearest Family History Center or you can purchase microfilmed records, or ask to have the microfilm digitized, from the North Carolina State Archives⁴ at a reasonable cost.

Search the *NCGS Journal (1975-2010)* on CD or the-soon-to-be-finished online index, for Buncombe County or the name of the ancestor you are searching as many from Buncombe County are mentioned in abstracted early newspaper and divorce records.

Conclusion

As always, when searching in a North Carolina county with record losses

- search records of the counties bordering Buncombe and the counties from which it was formed in 1791 as well as South Carolina and Tennessee counties that bordered Buncombe County and nearby Georgia counties;
- search the state and federal records;
- search district court records; and
- search private records.
