

Moore County, North Carolina

We have all heard the expression "more is less" and nowhere is that more appropriately applied than to Moore County, North Carolina, where a courthouse fire in 1889 destroyed most of its records. As recorded in the 12 September 1889 newspaper, The Carthage Blade, "The loss from this office [clerk's office], was about 500 judgment rolls, all probate papers, most of the old court minutes and dockets, all guardian books and bonds, all administrator's bond books, all Supreme Court Reports and Acts of the Legislature. All other books and papers are saved. Every paper and book in the Register's office, including the 1889 tax books (which had not vet been quite finished) was lost. So was everything in the County Superintendent's office also lost." A full account of the fire can be found in the May 1989 issue of the NCGS Journal.¹

Moore County was formed in 1784 from Cumberland County. In 1850 and before, Moore County bordered Cumberland, Richmond, Montgomery, Randolph, and Chatham counties. Although somewhat bleak, below is a list of the records before 1850 that survived. Other early records of Moore County residents can be found in public and church newspapers, early divorce records, runaway slave advertisements, Supreme Court cases, federal tax lists, and other compilations of records that were not in the Moore County Courthouse that somber night. Many of these are abstracted in the *NCGS Journals*.

- Mortgage Deeds and Deeds of Trust, 1 fibredex box 1834-1926
- Miscellaneous land records, 2 fibredex boxes, 1798-1926 and no date
- Land entries, 1784-1795

Although the early Moore County court records have not survived, some court dockets have. The docket is a list of court cases to be heard on a particular day. Not a lot of detail is given but the names of the parties involved, what type of case, and sometimes a few details are provided.

Many of the original records found at the North Carolina State Archives are also on microfilm. If the records are not on FamilySearch, you can order a copy of the microfilm or a digital copy of the microfilm for a minimal cost from the North Carolina State Archives. Microfilm can be read at any library with a microfilm reader and at a local FamilySearch (Family History) Center.

Rassie Wicker, *Miscellaneous Ancient Records of Moore County, N.C.* (No place: by the author, no date). This book of abstracts contains Cumberland County land grants and deeds 1754-1784 (Moore County was created from Cumberland County in 1784), the 1815 tax list, census records, etc.

Patrick K. McDonald, *A History of Highland Scots Immigration into Moore County* (Franklin, NC: by the author, 2002). This book of abstracts contains a plat map of Moore County land grants near McLindon's Creek and the Juniper along with vignettes of Scottish families of this area.

Duncan McLeod and Barbara Kelly, *Emigrants from Parish of Sleat, Isle of Skye, Scotland to Moore County, NC, USA Circa 1802 and Their Descendants* (No place: no publisher, 1994). James Vann Comer sells this book.
